

CLERGY SERVING IN THE DIOCESE OF SACRAMENTO WHO HAVE BEEN CREDIBLY ACCUSED OF SEXUAL MISCONDUCT WITH CHILDREN/YOUNG PEOPLE

DIOCESAN PASTORAL RESPONSE TO THE PEOPLE OF GOD WHEN THE PRIEST WAS REMOVED DUE TO CREDIBLE SEXUAL ALLEGATIONS AGAINST MINORS: Since the establishment of the Dallas Charter of 2002, in almost all cases, the diocese informed the parishioners from the pulpit of the removal of the clergy member and asked if there were any more victims. We encouraged victims to contact law enforcement (we offered contact numbers to local law enforcement). If the victim is a minor or includes other illegal conduct, the diocese immediately reports it to law enforcement and any other pertinent authorities. The diocese cooperates fully with any law enforcement response. In addition, with those victims that came forward, we offered counseling.
