FIRST AMENDED

COMPLAINT -- CRIMINAL

The undersigned, complains and alleges, upon information and belief, that said defendant(s) did commit the following crime(s) in the County of Stanislaus, State of California.

COUNT I: On or about September 12, 2020, defendant(s) **JOVONNA LEE CRUZ** did commit a felony, CHILD ABUSE CAUSING DEATH, violation of Section 273ab(a) of the California Penal Code, in that the defendant(s) did willfully, unlawfully, and feloniously, having care and custody of a child under eight years of age, **DAVID T., SEVEN (7) YEARS OF AGE**, assaulted said child by means of force likely to produce great bodily injury, resulting in the child's death.

COUNT II: On or between January 1, 2020, and September 11, 2020, defendant(s) **JOVONNA LEE CRUZ AND EYVAR OMAR RIVERA** did commit a felony, PERMIT CHILD TO SUFFER UNDER CIRCUMSTANCES LIKELY TO CAUSE GREAT BODILY INJURY OR DEATH, violation of Section 273a(a) of the California Penal Code, in that the defendant(s) did willfully, unlawfully and feloniously, under circumstances and conditions likely to produce great bodily harm and death, cause and permit **DAVID T.**, a child, **SEVEN (7) YEARS OF AGE** to suffer and inflict upon said child unjustifiable physical pain and mental suffering, and having care or custody of **DAVID T.**, said child, willfully caused and permitted said child to be placed in a situation where his person or health was endangered and willfully caused or permitted the person or health of said child, to be injured.


